DALLAS COWBOYS APP

Enhance your experience at the stadium by downloading the Dallas Cowboys App. You can view the event day schedule, use navigation maps to get around the stadium and see traffic routes, feel safe by being able to effectively notify security, and more!

AT&T CELL PHONE CHARGING STATIONS

Complimentary phone charging stations are located on the east main level platform, just inside the Entry C doors by the AT&T East Plaza. There are four stations, each with (12) individual lockers that are equipped with cables to charge all iPhone and Android devices. Guests should simply enter the letter "C," followed by a unique code that will allow them to place their phone in the locker to charge. If a guest leaves their phone in the locker, or forgets their unique code, phones will be brought to the Guest Services Center at Section 244 where our staff can unlock the lockers with a key, or reunite the guest with their lost phone.

POST-EVENT UBER PICK-UP

Go to Lot 15 to pick up your Uber ride! Lot 15 will be the Uber pick-up location for every major event at AT&T Stadium.

ADA/ ACCESSIBILITY

AT&T Stadium is committed to serving guests with disabilities. Our facilities are fully accessible and we provide a wide range of services and amenities for guests with special needs. Guests can receive more information by visiting one of our Guest Services Centers located on the concourse behind Sections 219, 244, 420 and 451. Animals are not permitted in AT&T Stadium with the exception of service animals and service animals in training. For more information, please contact the Guest Services Hotline at (817) 892-4161.

PROHIBITED ITEMS

Bags, purses, outside alcohol, food items*, bottles, cans and beverage containers of any kind*, coolers*, weapons of any kind, laser pointers, footballs, signs or flags on sticks, noisemakers, tripods, monopods and cameras with lens larger than 3" (detachable or non-detachable), video cameras, chairs, stools or other seating devices. *Exceptions will be made for Guests with special medical needs.

SECURITY SCREENING

All guests entering AT&T Stadium are subject to a physical security screening of their person and accompanying items. The physical screening consists of a walk-through metal detector sweep. Please remove cell phones or larger metal objects from your pockets prior to screening. Guests who wish not to be screened by metal detector may elect a physical pat-down screening as an alternative. All other articles will be visually inspected. Items in sealed/wrapped boxes must be opened for inspection.

CODE OF CONDUCT

AT&T Stadium Management is committed to creating a safe, comfortable and enjoyable experience for our guests. Our staff will proactively support an environment free from the following behaviors: Abusive, foul or disruptive language and obscene gestures, intoxication or other signs of impairment related to alcohol consumption, fighting, taunting or threatening remarks or gestures, sitting in a location other than the guest's ticketed seat, displays of affection not appropriate in a public setting, obscene or indecent clothing, any disruption to the progress of the event by the guest's actions.

AT&T STADIUM BAG POLICY IN EFFECT

The AT&T Stadium Bag Policy is in effect for this game. AT&T Stadium instituted the National Football League's policy that limits the size and types of bags entering AT&T Stadium on event days. The policy is a league-wide initiative intended to enhance public safety for events at NFL stadiums across the country. The NFL strongly encourages fans to not bring any type of bags to the venue. However, should bags be needed, approved items include:

- Clear plastic, vinyl or PVC totes that do not exceed 12" x 6" x 12"
- Clear one-gallon re-sealable storage bags
- Small clutch purses/bags approximately the size of a hand – not to exceed 5.5" x 8.5" in size – with or without a handle or strap

Prohibited bags include, but are not limited to: purses larger than a clutch bag, coolers, briefcases, backpacks, fanny packs, cinch bags, seat cushions, luggage of any kind, computer bags and camera bags or any bag larger than the permissible size. AT&T STADIUM PURSE/BAG POLICY

In an effort to enhance public safety, AT&T Stadium has modified its security policy by limiting the size and style of bags allowed in the stadium.

PROHIBITED BAGS

PROHIBITED ITEMS INCLUDE, BUT ARE NOT LIMITED TO:

- All purses, bags or containers larger than a small clutch bag
- Backpacks
- Binocular case
Binoculars may be worn around the neck
- Briefcases
- Camera bags
- Cinch bags
- Computer bags
- Coolers
- Fanny packs
- Luggage of any kind
- Seat Cushions



APPROVED BAGS

CLEAR TOTE
Plastic, vinyl or PVC and do not exceed 12"x6"x12"



PLASTIC STORAGE BAG
Clear, one (1) gallon, re-sealable



OR

SMALL CLUTCH PURSE
Approximately the size of a hand with or without a handle or strap. No larger than 5.5" x 8.5" (the size of this sheet) with or without a handle or strap. Can be carried separately or within an approved plastic bag.



An exception will be made for medically necessary items after proper inspection at a gate designated for this purpose. Please limit the number of items you bring to the stadium on event days.

TAILGATING GUIDELINES

All guests wishing to tailgate must observe the following guidelines. These guidelines have been developed to provide a fair, reasonable and safe tailgating experience for guests. Failure to follow these guidelines may result in the loss of tailgating privileges and ejection from the parking lot.

TAILGATING POLICIES

- Grass parking spaces are for vehicles only. Trailers, tents, grills, chairs or other items are not allowed in the grass vehicle parking spaces.
- Vehicles must be parked as illustrated here and may only occupy one grass parking space.
- Vehicles may not extend more than 18 inches into the paved drive aisle.
- Each grass parking space is allowed a maximum tailgating space of 9 feet wide by 12 feet deep immediately behind the parked vehicle.
- Any grass areas beyond the designated tailgating spaces are considered common ground and may be used by other guests for tailgating or picnicking activities.
- Sidewalks, roads and parking drive aisles must remain clear at all times.
- Tailgating is defined as the placement of any item on the ground (tents, chairs, coolers, grills, games, etc.).
- All guests must follow the directions and instructions provided by stadium personnel (parking staff, security, police, etc.).
- Dispose of trash in the appropriate receptacles.
- Coals must be disposed of in the designated coal containers located throughout the lots. Do not dump coals or store stoves on the grass, parking areas, under or around vehicles.

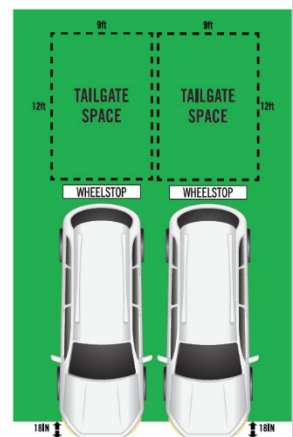
TAILGATING PROHIBITED ITEMS

- Deep fryers or any oil-based cooking or frying
- Open flame fires of any kind (charcoal and gas cooking is permitted)
- Disorderly conduct
- Picketing, political campaigning or soliciting/distributing of any kind
- Saving parking or tailgating spaces for others
- Weapons and fireworks
- Sale of food, beverage, merchandise, etc.
- Advertising or promoting any third party products (including but not limited to food and beverage products)
- Amplified sound systems or the use of radios/audio devices at loud levels or that include lyrics with inappropriate language.
