With regular season games remaining in the 2023 season, playoff teams and sites have not yet been determined. Pending the outcomes of the remaining games, there is a chance for the Dallas Cowboys to host a home playoff game(s) at AT&T Stadium. Due to the NFL Playoff format, it is possible to host up to three home playoff games.

## Pay As We Play - Online Only

You have the opportunity to pay for playoff games at AT&T Stadium as they are clinched. By signing up for "Pay As We Play," your card is securely stored and will be charged for the contractual amount of tickets in your suite for the 2023 season only when it has been determined that the Cowboys host a home playoff game(s). A charge if the first game clinched is a Wild Card game, a second charge will be made for the Divisional Playoff game (if applicable) and a third charge will be made for the NFC Championship game (if applicable). If you have an account credit, it will be applied to your playoff invoice and the balance will be charged to your card.

Deadline to enroll in the "Pay As We Play" option is Friday, January 5, 2024 at 5pm.

To enroll in "Pay As We Play," log in to your Dallas Cowboys Account Manager, www.SeatGeek.com/Cowboys, and select Offers.

Your invoice reflects the cost of tickets to game 11, the Wild Card Game, game 12, the Divisional Game and game 13, the NFC Championship. To pay in full and reserve your suite for the playoffs, you must purchase your tickets for all

potential playoff games by Friday, January 5, 2023 at 5pm.

Pay online by logging in to your Dallas Cowboys Account Manager, www. SeatGeek.com/Cowboys, and select Payment.

If the Cowboys do not host a playoff game(s) for which payment was received, the Ticket Office will apply the credit to your account to be used towards future events. If you would prefer to receive a refund, please send an email to your Suite Service Coordinator. Be sure to reference your account number. Refunds will begin processing in February.

Refunds will be issued according to the method of payment used for the playoffs. ALL REFUND CHECKS WILL BE MADE PAYABLE TO THE SUITE ACCOUNT HOLDER OF RECORD, REGARDLESS OF ORIGIN OF PAYMENT.
